Instructions for submitting an abstract

You are invited to submit an abstract before December 15th. **Acknowledgment of receipt will be sent automatically. If you do not receive any acknowledgment, please contact us again.**

For talks, a maximum of two abstracts will be accepted for each speaker. All authors of accepted abstracts must register and be paid in full by the early registration deadline (currently February 2018). Authors failing to comply with this rule will not be included in the Conference Programme.

Oral (spoken) presentations will be limited to 20 minutes: 15 minutes for presentation and 5 minutes for questions. Contributed oral presentations will be grouped by topic. If your abstract is accepted but cannot be accommodated as an oral presentation, we may offer you the opportunity to present a poster. All oral presentation rooms will be equipped with a computer and a data projector. Poster presenters will receive general instructions on poster format once the abstract is accepted. Detailed information and instructions on presentations at the meeting will be available to presenters several months before the meeting.

Abstract (limited to 150 words)	Qualitative research in the field of conservation and environmental management is growing rapidly, and systematic approaches to synthesis of this research are needed. Evidence from the synthesis of qualitative research can provide a more nuanced view of intervention effectiveness, may facilitate a better understanding of the implementation context, and build novel theories. Such qualitative evidence syntheses may stand alone as independent reviews, be directly linked to a quantitative synthesis on a related question, or may be part of mixed methods

	<p>synthesis that brings these two bodies of evidence together. In the field of environmental management and conservation no methodological guidelines for synthesis of qualitative environmental research yet exist. In a first attempt to begin developing guidance, this presentation will provide a brief overview of methods that can be used to synthesize environmental research and it will explain the importance of such syntheses to inform environmental policy and practice.</p> <p>Link with a theme: “Synthesis of qualitative environmental research: how, when and what?”</p>
